We, the undersigned natural persons of the age of eighteen (18) years or more, at least two (2) of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME

The name of the corporation is Birch Creek Forest Properties, Inc.

ARTICLE TWO

NONPROFIT CORPORATION

The corporation is a nonprofit corporation.

ARTICLE THREE

DURATION

The period of its duration is for fifty (50) years.

ARTICLE FOUR

PURPOSES

The purposes for which the corporation is organized are to have and exercise all rights and powers conferred on non-profit corporations under the laws of Texas, or which may hereafter be conferred, including the power to contract, rent, buy or sell personal or real property; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in

furtherance of the primary purpose of this corporation.

Additionally, without limiting the foregoing, the corporation shall dispense and operate any maintenance funds and conduct any general maintenance duties and obligations pertaining to lands in Burleson County, Texas, which the corporation owns or is affiliated with.

#### ARTICLE FIVE

##### INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 5051 Westheimer Road, Houston, Texas, and the name of its initial registered agent at such address is J. R. Imber.

#### ARTICLE SIX

##### BOARD OF DIRECTORS


